## **All India Council for Technical Education (AICTE)**

As per AICTE Notification No. UB/04(03/2010) University does not require prior approval of AICTE to commence a new department or course & program in technical education. Only institutions which are affiliated to Universities require approval. As Arunodaya University is a Bonafide University established by a State Act, it does not require AICTE approval.

## **ELIGIBILITY OF ARUNODAYA UNIVERSITY DEGREES FOR NATIONAL AND INTERNATIONAL TESTS FOR HIGHER EDUCATION**

Like any UGC recognized Degrees of any University in India, students passing out from Arunodaya University are eligible to apply examinations like UGC-NET, GATE, CAT, UPSC, GMAT, GRE, JRF, etc.



# GENERAL INSTRUCTIONS



Candidates are advised to go through the information Brochure before filling up the admission form & follow other instructions from time to time written in information Brochure as well as on the Arunodaya University website.



The candidate shall remain in touch with the University for getting a receipt of fees, evaluation / admit card, marks cards etc.



University shall not be responsible for delay in submission of new admission, Re-registration forms due to postal delays or courier or any other mode.



All candidates will be admitted provisionally subject to the checking of eligibility, verification or other admission formalities. Eligible candidates will be issued an enrollment number.



A student has to fill up & submit the re-registration form with the requisite fees for entry to next semester or year of the course already enrolled.



The candidates appearing in compartment/re-appear paper of any lower class from this University are required to communicate the result of the lower examination, when declared, immediately to get the result declared on time.

# ADMISSION PROCEDURE

1. Arunodaya University offers admissions to wide range of programs ranging from Diploma, Under Graduate, Post Graduate & Ph.D.

All admissions shall be based on the application/admission Form received in response to the admission notification. Selection will be on the basis of performance in last qualification exam/ entrance test/personal interview and also on scores of national and state level entrance examination (wherever applicable).

2. Application for admission to various programs can be submitted online through university website [www.arunodayauniversity.ac.in](http://www.arunodayauniversity.ac.in). In case a candidate is not able to apply online, he / she may download /obtain the application from the University website and submit the duly filled-up application form along with eligibility documents and a non-refundable Application Processing Fee of Rs.1000/- either via online mode or by (Demand Draft in favour of "Arunodaya University" payable at Itanagar) to the admission department of University. Same admission form is applicable for all the courses.

3. Duly completed application form for admission in the program of study must reach the University as per prescribed date.

4. Kindly note that merely submission of an application form does not constitute a claim for admission as a matter of right. The application form may be rejected due to discrepancy in the supporting documents, or any other valid reason. University also reserves the right to refuse admission in any individual case without assigning any reason.

5. Admission is given provisionally. The offer of admission will automatically stand cancelled if the conditions are not fulfilled within the stipulated time. Failure to pay the fee within the specified date or report for classes after payment of fee will entail in cancellation of admission.

6. A candidate shall be considered as admitted to a program of Study and be eligible to avail the privileges of a student of the University only after he/she has completed all admission formalities including payment of the prescribed fees. If a candidate fails to complete the admission formalities by the prescribed date, he/she will automatically forfeit his/her right to admission.

7. Fill in the Application Form only if you meet the eligibility for admission to the programs of study. Duly filled application form will be allowed for submission only along with the following.

- ♦ Copy of Certificates, Diplomas, Degrees, Marks-Sheets of all educational qualifications.
- ♦ Aadhar Card copy, Photo-id and Address proof.
- ♦ Migration/ Leaving Certificate from Previous University/Institute.
- ♦ A valid personal E-Mail ID and Contact Number
- ♦ In case of the working students, a No Objection Certificate (NOC) from the employer clearly mentioning that the employer has no objection to the candidate's pursuing higher education in the Arunodaya University on full time / part time basis.
- ♦ Caste/Tribe/domicile certificate issued by the competent authority.
- ♦ In case of gap between the qualifying examination and the year of seeking admission in the University, the candidate shall be required to submit an affidavit indicating the reasons for such gaps and the activities in which she/he was engaged during the intervening period.
- ♦ Affidavit      ♦ Four Passport size latest colour photograph.

8. Incomplete forms will be rejected. No additions subsequently will be allowed and a new form has to be submitted in this case. The application processing fee and information brochure cost will not be refunded for any reason whatsoever.

9. The student shall be required to present original eligibility documents for verification as and when required by University. The University reserves the right to cancel admission/withhold result, if requires document(s) are not submitted.

10. In case of any confusion or further enquiry student can visit to our office during working hours and meet our education counsellor for the same.



# ANTI RAGGING

1. As per the orders of the Hon'ble Supreme Court, Ragging is a Grievous offence. Anyone indulging in ragging will be severely punished. The punishment may take the form of expulsion from the university, suspension from the classes for a limited period or fine with a public apology. The punishment may take the shape of

- a) Reporting to the police and lodging an FIR.
- b) Withholding scholarships or other benefits.
- c) Debarring from representation in events.
- d) Withholding results.
- e) Suspension or expulsion from the hostel or mess, and the like.

If the individuals committing or abetting ragging are not/can not be identified, collective punishment may be awarded to act as a deterrent.

2. All cases of ragging will be referred to the Anti Ragging committee of the university.

3. The following will be termed as the act of ragging:

Any disorderly conduct whether by words spoken or written or by any act, which has effect of teasing, treating or handling with rudeness any other student(s), indulging in rowdy or in disciplined activities which may cause or are likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension there of in fresher or junior student(s) or asking the student(s) to do any act or perform something, which such students(s) will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or Psyche of a fresher or a junior student.

4. All students enrolled in the university are bound by the directions of UGC and other regulatory bodies in respect of prevention of ragging in educational institution campuses.

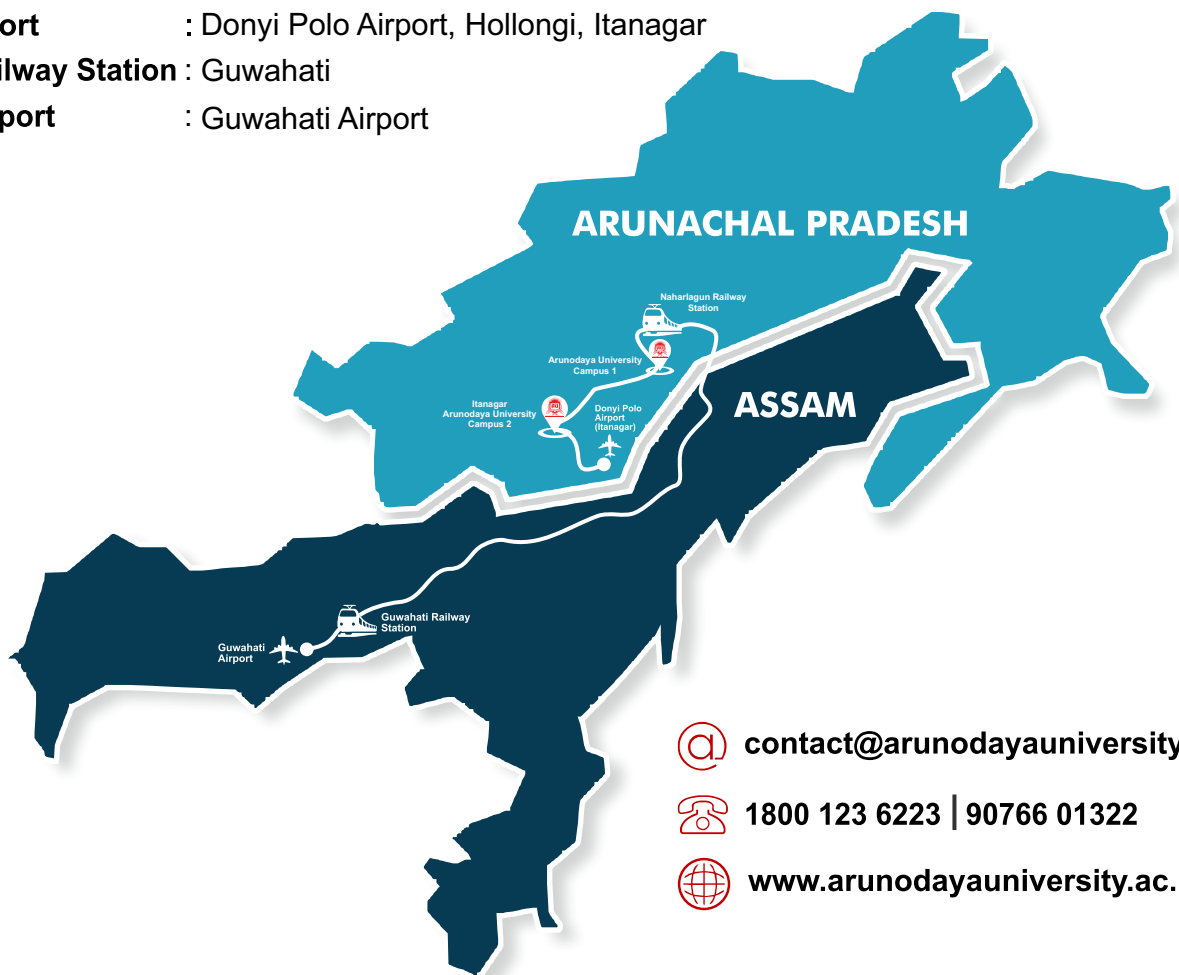
