# ALUMNI ASSOCIATION OF ARUNODAYA UNIVERSITY

### PART - I MEMORANDIUM

- 1. Name: The Name of the Association/Society shall be AU Alumni Association.
- 2. Address: Lekng Village, Naharlagun, Itanagar, Distt: Papum Pare, Arunachal Pradesh 791 110.
- 3. Juisdiction: The juisdiction of the Association shall be over India, but any dispute, case, suit shall be subject to the courts of Itanagar only.
- 4. Objective:
- a) To foster strong relation between AU Alumni and the others connected with the University in all fields.
- b) To realize the enormous benefit that can come from the engagement and support of AU Alumni with the University and seek their support in indentifying strategic directions for AU.
- c) To provide opportunities for community service to act as good will Ambassadors for AU within India and Abroad.
- d) To provde for academic and professional interaction and networking among AU Alumni and Endeavour to create opportuities for AU student community.
- e) To prove assistance and facilities for all round development of the university.
- f) To encourage the members to make actives interest in the activities and progress of the Alma-Mater.
- g) To initiate various welfare measures and activies so as to establish strong bond between the alumni and the University.
- h) To leaveare the power of alumni through networking and to maintain strong alumni database.

#### PART – II RULES AND REGULATIONS

- 1. Membership:
- a) All Alumni of the Arunodaya Univeristy who have complete minimum 1 year of Course shall be eligible for life membership of the Association. They shall have voting rights.
- b) The Vice Chancellor shall be the Ex-officio Patron of the Association and in that capacity shall enjoy all the privileges of a member.
- 2. Associate Member:

All present amd Ex-Employees can register themeselves as Associate member and they shall have no Voting Rights.

3. Cessation of Membership:

A member of the Association shall cease to be such a member if he/she resigns from his/her membeship or found to be unsoud mind or is convicted by a court of law for any offernce on moral grounds or termination of the membership by the Executive Committee for compelling reasons.

4. Fees:

Every members shall pay a membership fees/annual of life members as decided by the University as per the AU Act.

5. General Body:

The entire members of the Association shall constitute the general body and shall meet once in a year at a designated place and time. The general body shall have the power to consider and decide on all matters relating to AU and provide board policy frame-work towords the funcating of the Association. The general body shall also elect an Exective Committee to carry on with the activities of the Association.

- 6. Exective Committee:
- a) The Management of Association and its activities shall be vested in an Exective Committee nominated by General Body for a three year term. Excetive Committee shall meet as many times as it feels deem fit. The Excetive Committee shall compise of President (One), General Secretry (One, Treasurer (One), Joint Secretry (One), Chief Advisor (Ex-Officio).
- The Association may create as many posts as equivalent to Jr.
   Secretry to undertake works of State/National and Global Alumni networks.

#### 7. Powers of Exective Committee:

- a) It shal decide all its matters mostly by consensus and if no consensus could be reached on any matter the same will be decided by a vote of 2/3<sup>rd</sup> of majority members present.
- b) The-Excetive Committee shall have financial power to oversee its activities such as open a back account. To received and spent money and to maintain proper account to create Alumni fund to futher the pupose as mentioned.
- c) It shall intitiate such other welfgare activities to foster bond between alumni and the university.

# 8. Chief Advisor:

The Chief Advisor shall be an official of the AU and the post will be Ex-officio. He/She will be official link between Alumni and the AU community.

# 9. Logo/Website:

The University logo or any other logo shall be used and all activity, membership forms etc shall be placed in the website.

#### 10. Amendments:

Any proposed amendments shall be circulated to members as far as possible of the Association along with the notice for amendment meeting.


