



## Admission Procedure for International Students

International students are welcome to apply for admission to the various academic programmes offered by Arunodaya University. The International Students' Cell (ISC) serves as the single-window facilitation centre for all foreign nationals seeking admission to the University.

### 1. Admission Requirements

A foreign national seeking admission to any programme at Arunodaya University shall be required to submit the following documents issued by the competent authorities:

a. An **Equivalence and Eligibility Certificate** issued by the Association of Indian Universities (AIU), AIU House, 16 Kotla Marg, New Delhi – 110002.

b. A valid **Student Visa** obtained from the Indian Mission (Embassy/High Commission/Consulate) in the applicant's home country prior to arrival in India.

*Students from SAARC countries may be granted provisional admission on a Tourist Visa, subject to submission of a valid Student Visa at a later stage.*

c. Provisional admission may be granted upon submission of the documents mentioned at Serial Nos. 1(a) and 1(b). Confirmation of admission shall be subject to completion of all other formalities in accordance with Arunodaya University rules.

d. Preference shall be given to foreign students sponsored under Cultural Exchange Programmes of the Government of India.

### 2. Seat Allocation

Ten percent (10%) supernumerary seats shall be available for admission of foreign students, including Persons of Indian Origin (PIOs), in each programme and department of Arunodaya University, in accordance with UGC and Government of India norms.

### 3. Medical Examination

All international students must undergo a medical fitness examination, including tests for HIV and Tuberculosis, prior to final admission.

### 4. Hostel Facilities

Separate hostel accommodation shall be provided for international students, subject to availability.



## 5. Admission Test Exemption

Foreign students shall be exempted from appearing in the admission test for any programme, provided they submit letters of recommendation from a teacher/professor certifying their academic suitability for the programme applied for, along with duly authenticated academic transcripts issued by the competent authority.

## 6. Post-Arrival Formalities and Compliance

- a. All foreign students must report to the International Students' Cell immediately upon arrival at the University campus.
- b. Foreign students must report to the Foreigners' Branch of the Superintendent of Police (SP) Office immediately after arrival in India.
- c. Foreign Registration must be completed within fourteen (14) days of arrival in India, as per Government of India regulations.
- d. All foreign students shall provide an emergency contact number from their home country to the International Students' Cell immediately upon arrival at the campus.
- e. Any involvement of a foreign student in anti-national or illegal activities shall result in summary cancellation of admission without prior notice.
